# Missouri Division of Tourism (MDT) Juneteenth Grant Event Funding Application Criteria

Eligible areas: Statewide

**Eligible applicants**: Nonprofit organizations, destination marketing organizations (DMOs), city and county governments.

**Note for applicants**: Applications for events in cities with a population of fewer than 50,000 residents may only receive funding for one Juneteenth event. The number of applicants, available funding at the time of application, projected event attendance, and the application score will be considered in making this determination.

### **Important Dates:**

- Application submission opens July 15, 2023
- Deadline for applications is August 31, 2023
- Notifications to awardees will be sent September 30, 2023
- Disbursements begin in November 1, 2023.
- Summary of event due back to MDT by July 31, 2024

## Eligible uses of grant funds

This grant covers eligible costs and expenses related to development and activation of a 2024 Juneteenth celebration.

Grant funds may be used to cover costs associated with, but no limited to: venue rental and usage, event marketing and advertising, live entertainment, security, event staging, clean up, food vendors, volunteer support, non-alcoholic beverages, audio/visual equipment. Grant funds cannot be used for staff salaries or to provide compensation to volunteers.

Administrative costs, such as printing, mailing and material purchases (paper, mailing supplies, etc.) may be covered by the grant, but shall not exceed 10 percent of the total grant amount.

Publicly accessible works of art related to Juneteenth or that represent Black history and culture in the area in which the work is placed, including murals, markers, plaques and sculptures may also be funded as part of the application process. The cost of such works must be 50 percent or less of the overall amount of the applicant's grant request. MDT has no local authority; as such, applicants must follow all local regulations in accordance with all ordinances, city codes and other local rules that govern the placement of public art.

#### **Funding limits**

Applicants may request grants in amounts ranging from \$1,000 to \$150,000.

Cities with a population of fewer than 50,000 residents may only receive funding for one Juneteenth event. The number of applicants, available funding at the time of application, projected event attendance, and the application score will be considered in making this determination.

## Application/Approval Procedure

Applications submitted to MDT will be reviewed and scored to determine the eligibility of the event based on criteria below.

- Grant funds must be used for an established event of at least three years or an event that has previously received Juneteenth Grant funding from MDT.
- The estimated attendance for the event is 500 people or more, based on attendance history at prior years' events.
- The event must feature educational components on the historical significance of Juneteenth, including but not limited to lectures, storytelling, interpretive art, etc.
- The applicant must provide a Missouri charter number and be in "good standing" with the Missouri Secretary of State's Office.
- The applicant must be registered in the Missouri Buys system.
- The applicant must be enrolled in the federal E-Verify program or complete an attestation confirming that the applicant organization is staffed by volunteers and has no paid employees.

## Additional elements that may improve the application

The following items will be considered in the application review process and may impact the level of funding available to the applicant.

- The event should draw attendees from more than 50 miles (the standard tourism industry definition of tourism).
- The applicant's budget provides details on how the event will be marketed outside of the local community (examples of the markets and outlets were advertising will be placed).
- The event spans multiple days and includes multiple events.
- The event features programming for youth ages 18 and younger.

In the event an application fails to meet one of the above-posted criteria, but otherwise aligns with the objectives of Juneteenth grant funding, the Division of Tourism reserves the right to provide grant support to that event.
